Directions to the Quincy Marriott

From Boston and points North: Take Route 93 South. At the Route 93/Route 3 split, take the left exit number 7 onto Route 3 South towards Braintree/Cape Cod. Take your next exit, exit number 18, towards the Quincy T Station. Keep left at the fork in the ramp. Merge onto Thomas S. Burgin Parkway. Turn left at the traffic light onto Centre Street. At the next light, bear left onto Crown Colony Drive. Take the second left onto Marriott Drive and the Marriott will be up the hill on your left.

From West of Boston: Take Route 95 South to Route 93 North. Take the Route 3 exit, exit number 7, towards Cape Cod. Take the Washington Street exit, exit number 18, towards the Quincy T Station. Keep left at the fork in the ramp. Merge onto Thomas S. Burgin Parkway. Turn left at the traffic light onto Centre Street. At the next light, bear left onto Crown Colony Drive. Take the second left onto Marriott Drive and the Marriott will be up the hill on your left.

From the South: Take Route 95 North to the Route 93 North exit, exit number 12. Take the Route 3 exit, exit number 7, towards Cape Cod. Take the Washington Street exit, exit number 19, towards Quincy T Station. Keep left at the fork in the ramp. Merge onto Thomas S. Burgin Parkways. Turn left at the traffic light onto Centre Street. At the next light, bear left onto Crown Colony Drive. Take the second left onto Marriott Drive and the Marriott will be up the hill on your left.

From the South Shore: Take Route 3 North to the Quincy Center T Station exit, exit number 19. Merge left onto the Thomas S. Burgin Parkway and get as far left as possible. Turn left at the first traffic light onto Centre Street (directly across from the T station). At the next light, bear left onto Crown Colony Drive. Take the second left onto Marriott Drive and the Marriott will be up the hill on your left.

***Attention:** The exit number changes from exit 18 to 19 depending on which direction you are coming from. We recommend you confirm the driving directions from your starting point via the internet.
