Dear MassAHU Member:

Six months remain to the 2009/2010 Legislative Session that ends July 31st. MassAHU's legislative priorities are: **H-975** which would add a member in good standing of MassAHU onto the Health Insurance Connector Authority's Board of Directors; **H-997** that would stabilize premium increases on existing LTC insurance policies; **S-462** that would establish standards for LTC insurance and **H-4552** (S-2170) that would provide immediate and significant savings for small businesses by requiring health plans and providers to control their costs and could cut premiums for small businesses by as much as 22% from comparable products.

If MassAHU is to be successful in getting these bills signed into law, we cannot do it without your help.
